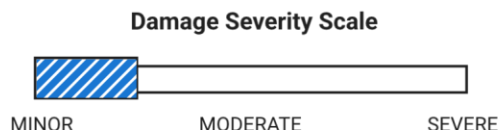



Glossary

Damage Indicator

Damage Severity

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership.
